Fees. The annual fee for a solid waste hauler permit is \$50 per vehicle and \$20 to transfer an existing license to another vehicle. All permits must be renewed on or before November 1 of each year. Pro-rata fees are not available. In addition, Chapter 12, Section 12-38, of the Port Huron City Code states that ". . .No license shall be issued to any person who is indebted or obligated to the City for any sum of money, other than for current taxes."
